## Meeting results:

### 1<sup>st</sup> June 2015 - results

SavaParks Declaration has been signed by 5 new project partners (**Annex 6**).

#### Pilot project outlines:

- 1) Nine project outlines submitted by end of May 2015 from various applicants
- 2) Evaluation of each project outline by 30<sup>th</sup> June 2015
- 3) Revised full project proposals have to be submitted by 7th August, 2015
- 4) Applicants will be informed on decision by September 15, 2015
- 5) Project duration by September 2016

#### Guiding principles should be included:

- 1) In the management documents on the international and national levels e.g., Danube and Sava river basin management plans, national water and nature management plans etc.
- 2) SavaParks network (Goran Gugić as the network spokesman) should send an official letter to the national institutions to inform responsible ministries and other decision makers on the SavaParks network, signed declaration and guiding principles (until 30<sup>th</sup> June)
- 3) Guiding principles should be send to the EC (DG Environment, DG Regio), ICPDR and ISRBC by SavaParks network and EuroNatur

### 2<sup>nd</sup> June 2015 - results
